From: School District Income Tax

Senate Bill 28 (effective July 1, 1998) makes it possible for school districts in Ohio to collect a School District Income Tax (SDIT) from residents who live in the district. The SDIT is a withholding tax separate from federal, state, and city income taxes, which is earmarked specifically for the operation of a school district. A school district must have a SDIT approved by voters just like a property tax levy.

We are required by Ohio Revised Code Section 5747.06 (E), to request from all of our employees their school district of residence. You are required to file this information even if your district of residence has not passed an SDIT. I have placed the names and four digit code for several school districts in our geographic area on the back of this form. This should help you identify your district's identification number requested on the form below. Your exemptions for SDIT will be the same as they are for state income tax withholding purposes.
