Dear Parent or Guardian:

We are pleased to inform you that Middletown City School District will again be implementing a new option available to schools participating in the National School Lunch and School Breakfast Programs called the Community Eligibility Provision for School Year 2025-2026.

What does this mean for you and your children attending Middletown City Schools? Great news for you and your students! All enrolled students at Middletown City Schools are eligible to receive a healthy breakfast and lunch at school for NO CHARGE to your household each day of the 2025-2026 school year. No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit an application.

Breakfast will be available for all students upon arrival at their building. Please encourage your child(ren) to visit the breakfast line each morning to select and eat their breakfast.

A 'la carte items will be available daily, but cash sales will be the only form of transaction. Should you desire your child(ren) to have a snack, please send them with the money for that specific day. If we can be of any further assistance, please contact us at (513) 217-2725.
